In God We Trust

To the Honorable Governor Kevin Stitt,

Sir,

We, the undersigned write to you today asking you to use your executive authority in accordance with the Constitution of the State of Oklahoma to call a special session of the Oklahoma legislature for the purpose of prohibiting mandatory "vaccinations".

Each of us daily receives e-mails and phone calls requesting that we use our legislative authority or professional reputation to protect them. We have all seen the Biden administration inform Americans that a government official is going to go door to door "to convince you to take the "vaccine."" This is a violation of our State and federal Constitutions. The people of Oklahoma expect us to use our office or position of influence to protect their rights. We never envisioned a day where the government - in America - would do this.

Many are threatened with termination from their employment if they do not submit to this experimental "vaccine" - for a disease with a 99.7 percent survival rate. They have refused "vaccination" for good reason! The Vaccine Adverse Event Reporting System (VAERS) reports almost 12,000 deaths from this "vaccine" alone from December 2020 until now. It is essential to note that this number is for the covid vaccine ONLY and that the total number of deaths from all other vaccines combined from 2009 - 2019 is 1,529. Further, as of June 18, VAERS reports more than 11,000 injuries in children 12 to 17 who have been "vaccinated" for covid. A Harvard Pilgrim Study completed in 2010 found that only 1 to 10 % of all adverse vaccine reactions were even reported to VAERS, therefore the numbers above, while shocking, are likely low. The methods used - or tolerated by - our government are a violation of every one of the ten principles of the Nuremberg code.

The most important point is that no entity has the authority to compel an American to ingest or be injected with anything that violates their conscience. Our bodies are not the property of the state, but of God. We are merely the stewards. It matters not that the "vaccine" gains FDA approval, if it violates my conscience you (government or business) cannot compel me to take it. Informed consent is non-negotiable, "consent" being the key word.

For health care professionals, the hospital-mandated deadline is September 1st. Many, faced with the threat of financial ruin have already violated their consciences and put their health at severe risk in order to provide for their families. This is a clear case of "the poor being bought for a pair of sandals."

We the people are saying to our government, "if you are not going to protect my rights, I will."

Please remember your oath and protect our God-given rights. Like Mordecai said to Esther, "Do not think in your heart that you will escape in the king's palace any more than all the other Jews. For if you remain completely silent at this time, relief and deliverance will arise for the Jews from another place, but you and your father's house will perish. Yet who knows whether you have come to the kingdom for *such* a time as this?"
